Assessment Types & Fees

If a participant is assessed by VEA for quality but wants their NAS assessment at a different time to their quality visit they must pay the Non Quality Full fee (less the JF) and have a full NAS assessment.

If a participant is assessed by VEA for quality for one property but wants an NAS assessment for a different (non-quality) property they pay the Non Quality Full fee (including the Joining Fee in year 1) and have a full NAS assessment.

If a participant is a new applicant, or existing quality member who brings in NAS as new, they must pay the Quality - Full fee and have a full NAS assessment.

If a participant is assessed by VisitEngland Assessment Services for quality and answers yes to any of the questions (1-3 below) they must pay the Quality - Full fee and have a full NAS assessment.
